## **The Alliance for Responsible Mining (ARM) launches updated Fairmined certification system authorizing IMOsuisse AG (IMO) as Fairmined certification body for mining organisations**

The Alliance for Responsible Mining (ARM) and IMOsuisse AG (IMO) are happy to announce the signing of the final contract authorizing IMOsuisse AG to deliver sustainable, credible and transparent auditing and certification services to Artisanal and Small-scale Mining Organisations against the Fairmined Standard.

The launch of the certification and auditing system follows the recent publication of version 2.0 of the Fairmined standard that includes some important changes to provide new opportunities for Artisanal and Small-scale miners globally and for the market. The Fairmined Standard for gold and associated precious metals was developed with ARM's network for responsible mining and includes requirements for traceability, social development, conflict mitigation, economic development, environmental protection and labour conditions.

The Artisanal and Small-scale Mining Organisations wishing to be certified are audited by IMOsuisse AG that will determine their compliance with the Fairmined Standard requirements for mining. Certified Artisanal and Small-scale Mining Organisations receive a Fairmined minimum price for their gold and a premium, which is reinvested into community projects and improved mining operations. After obtaining certification the organisations undergo annual audits to assure their compliance with the development approach of the standard and their continuous improvement of conditions at mines, processing units and in the surrounding communities.

"IMOsuisse AG has a long track record in independent third party certification and we are very pleased to have such a well-recognized and experienced certification body on board as a part of our Fairmined certification system." Said Ronald Koepke from the Alliance for Responsible Mining.

The certification and auditing system is in line with international recognised procedures and methodologies for third party certification and auditing systems, and shall provide all users with transparent and comprehensive
